THE RURAL MUNICIPALITY OF HEADINGLEY

BY-LAW NO. 16/97

BEING A BY-LAW OF THE RURAL MUNICIPALITY OF HEADINGLEY authorizing the payment of a remuneration to members of Council.

WHEREAS subsection 124(2) of The Municipal Act S.M. 1996, c. 58, provides:

Council may set compensation and expenses

124(2) A council may by by-law set the types, rates and conditions of payments to be made to or on behalf of members of the council and council committees, other than the committee of a local urban district.

- (a) as compensation for attending to municipal business;
- (b) for expenses incurred while attending to municipal business; and
- (c) for any other purpose relating to municipal business that the council considers appropriate.

NOW THEREFORE, the Council of The Rural Municipality of Headingley enacts as follows:

1. Council and Committees

- (a) That an monthly indemnity of One Thousand Dollars (\$1,000.00) be paid to the Reeve;
 - (b) That an monthly indemnity of Eight Hundred Dollars (\$800.00) be paid to each Councillor; and
 - (c) That the aforesaid indemnities be paid to the Reeve and to each of the members of Council as remuneration for their attendance at meetings of council and committees thereof.

2. Travel Allowance

That each member of the Council of the Rural Municipality of Headingley be paid the sum of Twenty-eight Cents (\$.28) per kilometre for each kilometre actually and necessarily travelled by them in the performance of such duties, work, or services as they are authorized by the Council to perform.

3. Delegations, Conventions and Other Organizations to which the Rural Municipality of Headingley belongs

That each member of council actually engaged in travelling to, attendance at, and returning from any meeting of any organization that is in the interest of the municipality to belong, if authorized by resolution of Council for attendance outside the municipality, be paid

- (a) the actual travelling expenses and actual living expenses; and
- (b) Fifteen Dollars (\$15.00) per hour for less than half a day; or
- (c) the sum of Sixty Dollars (\$60.00) for a half day; or One Hundred and Twenty Dollars (\$120.00) for a whole day they are.

4. Indemnity and Expenses outside the limits of the municipality

That an indemnity be paid to any member of Council, travel allowance, actual living expenses, registration fee and tuition fee be paid to any member of council, officer or employee duly authorized by resolution of the Council specifying the purpose of the journey, to go beyond the limits of the municipality.

5. Repeal Previous By-Law

By-Law 31/95 is hereby repealed.
