Water & Wastewater funding

On April 30th, Premier Greg Selinger announced the Manitoba government will invest \$84 million over the next five years to improve and upgrade water and wastewater facilities in more communities outside of Winnipeg.

New projects that will be launched include \$1.5 million for water supply upgrades in the RM of Macdonald; \$2.3 million for new wastewater infrastructure for the RM of Sifton and the Town of Oak Lake; and \$1 million for upgrades and expansion of the wastewater lagoon in the LGD of Pinawa.

Premier Selinger said the Province is working with municipalities and the federal government to prioritize upgrading or replacing wastewater treatment facilities in several communities, along with a new water treatment plant in the RM of Headingley.

“Clean water is critical for the health and safety of our citizens as well as the growth of our communities,” said President Doug Dobrowolski, who joined the Premier and the Honourable Stan Struthers, Minister of Municipal Government, for the announcement. “Investments in water and wastewater infrastructure allow municipalities to remain sustainable while attracting new business.”

The province will soon be sending letters to all municipalities encouraging them to identify potential water and wastewater projects that could be cost-shared in the future.

Gas Tax renewed for 10 years

President Dobrowolski joined the Honourable Shelly Glover, Minister of Canadian Heritage; Manitoba Municipal Government Minister Stan Struthers, and other dignitaries at Winnipeg City Hall on May 2 to celebrate the renewal of the federal Gas Tax Fund for the next 10 years.

President Dobrowolski thanked the Government of Canada for renewing the agreement and making it permanent in legislation. He also thanked both the Province of Manitoba and the Government of Canada for working with the AMM on the Gas Tax Oversight Committee. “This partnership helps to ensure these important funds flow smoothly,” he said.

He also noted the ability to use 100% of gas tax funding toward eligible projects gives municipalities the flexibility and the control to get important projects off the ground.

“Municipalities are trusted by their citizens and capable of determining where infrastructure dollars should be spent,” he said. “The AMM has lobbied strongly for increases to municipal infrastructure funding, for shares of growth revenue, and for decision-making powers when it comes to funding infrastructure in our own local communities.”
