

THE RURAL MUNICIPALITY OF DAUPHIN BY-LAW # 2838



BEING A BY-LAW OF THE RURAL MUNICIPALITY OF DAUPHIN FOR FIRE PREVENTION WITHIN THE RURAL MUNICIPALITY OF DAUPHIN.

WHEREAS IT IS DEEMED EXPEDIENT AND ADVISABLE TO PASS A BY-LAW TO PROVIDE GENERALLY THE PROTECTION OF LIFE AND PROPERTY FROM DAMAGES BY FIRE AND TO REGULATE BURNING WITHIN THE RURAL MUNICIPALITY OF DAUPHIN.

NOW THEREFORE THE COUNCIL OF THE RURAL MUNICIPALITY OF DAUPHIN IN SESSION ASSEMBLED, ENACTS AS FOLLOWS:

- 1. THAT THE AUTHORITY HAVING JURISDICTION MEANS THE MUNICIPAL COUNCIL AND THE DULY APPOINTED AGENTS THEREOF.
- 2. A) THAT BURNING IS PROHIBITED WITHIN THE RURAL MUNICIPALITY OF DAUPHIN EXCEPT WHERE APPROVAL, IN THE FORM OF AN AUTHORIZED BURNING PERMIT, HAS BEEN OBTAINED. ALL BURNING PERMITS ARE ISSUED SUBJECT TO THE CONDITIONS STATED ON THE PERMIT.
 - B) THAT APPLICATIONS FOR BURNING PERMITS SHALL BE MADE AT THE ADMINISTRATION OFFICE, TO THE REEVE OR ANY MEMBER OF COUNCIL OF THE RURAL MUNICIPALITY OF DAUPHIN. THE PERMIT IS NOT VALID UNTIL ENDORSED BY A DESIGNATED OFFICER, BEING ANY ONE OF THE FOLLOWING: REEVE, COUNCILLOR, ADMINISTRATOR, ASSISTANT ADMINISTRATOR, OR THE CLERK ACCOUNTANT.
 - C) THAT THE COST OF A BURNING PERMIT SHALL BE AS PER RESOLUTION OF COUNCIL OF THE RURAL MUNICIPALLY, OF DAUPHIN.
 - D) THAT THE FOLLOWING WILL BE EXEMPTED FROM OBTAINING A PERMIT:
 - I) ANY FIRE THAT IS SET IN AN ENCLOSED CONTAINER FOR THE PURPOSE OF BURNING GARBAGE PROVIDED THAT WHILE THIS IS BEING BURNT A RESPONSIBLE PERSON MONITORS THE FIRE TO ENSURE THAT IT DOES NOT GET OUT OF CONTROL.
 - II) ANY FIRE THAT IS SET IN AN ENCLOSED CONTAINER OR LOCATED IN AN AREA OF DIRT/SAND THAT HAS BEEN SET FOR COOKING OR WARMTH AND WOULD NORMALLY BE CONSIDERED A "CAMP FIRE" PROVIDED THAT WHILE THIS IS BEING BURNT A RESPONSIBLE PERSON MONITORS THE FIRE TO ENSURE THAT IT DOES NOT GET OUT OF CONTROL.
 - III) SINGLE BALES OR PILES OF STRAW CREATED FROM TILLAGE PROVIDED THAT WHILE THIS IS BEING BURNT A RESPONSIBLE PERSON MONITORS THE FIRE TO ENSURE THAT IT DOES NOT GET OUT OF CONTROL.
- 3. THAT ANY PERSON CONVICTED OF A VIOLATION OR INFRACTION OF ANY OF THE PROVISIONS OF THIS BY-LAW, SHALL, UPON CONVICTION BE LIABLE FOR EACH OFFENCE TO A PENALTY NOT EXCEEDING FIVE HUNDRED (\$500.00) AND COSTS. IN ADDITION, THE PERSON CONVICTED SHALL PAY THE ACTUAL COSTS INCURRED, IF ANY, OF FIREFIGHTING AND EXTINGUISHING ANY RESULTING FIRE.
- 4. THAT IN THE EVENT THAT THE COUNCIL OF THE RURAL MUNICIPALITY OF DAUPHIN BAN BURNING FOR A CERTAIN PERIOD OF TIME DUE TO THE WEATHER CONDITIONS, ANY EXEMPTIONS AS STATED WITHIN CLAUSE 2(D) OF THIS BY-LAW, WILL BE PROHIBITED.
- 5. THAT BY-LAW NO. 2735 BE AND IS HEREBY REPEALED.
- 6. THAT THIS BY-LAW SHALL COME INTO FORCE AND TAKE EFFECT ON THE PASSING THEREOF.
