### Manitoba Household Hazardous Waste Stewardship Program Plan



Product Care Association will be holding public consultations for the renewal of the Manitoba Household Hazardous Waste Stewardship Program Plan (2023 – 2028).

The Manitoba Household Hazardous Waste Stewardship Program is the approved product stewardship program for residential paint, fluorescent lights (including Industrial, Commercial and Institutional), flammable liquids/gasoline, corrosives, toxics, physically hazardous materials and pesticides, managed and operated by Product Care pursuant to the <u>Manitoba Household Hazardous Material and Prescribed Material Stewardship Regulation</u>. The current <u>Manitoba Household Hazardous Waste Stewardship Program Plan</u>, which expires on June 31, 2023, was developed by PCA and <u>approved</u> by the Manitoba Ministry of Environment and Climate Change Strategy.

# Transport Canada's Rail Safety Improvement Program New Funding Stream

Transport Canada's Rail Safety Improvement Program (RSIP) provides federal funding in the form of grants or contributions to help improve rail safety, contribute to increasing safety at grade crossings and along rail lines, address climate change resilience, and increase public confidence in Canada's rail transportation system.

RSIP is launching a new **Climate Change and Adaptation to Extreme Weather Infrastructure** funding stream to support projects that:

- Support vulnerable rail infrastructure projects by ensuring resilience to extreme weather events and adaptation to climate change; and
- Address climate change resilience through the rehabilitation, mitigation, and/or prevention of the impacts of climate change/extreme weather along rail lines and rail property.

Examples of potential projects include: implementing erosion correction/control methods to repair damage from a flood and mitigate future damage, removing debris from tracks/rail crossings/rail property following an extreme weather event, installing soil stabilization measures such as dykes or retaining walls to reduce erosion, and implementing ecosystem-based approaches using natural infrastructure (e.g., planting trees) to design adaptation measures.

We will be holding an information session soon to provide an overview of relevant program information and answer questions on the program/application process. Please watch for an email in your inbox for registration details.


