Municipal Government Minister Stan Struthers, on a PST rebate for municipalities Since 2004, the AMM has held an annual Lobby Day. Although the AMM regularly meets with Provincial Cabinet Ministers, the mandate of Lobby Day is for the AMM Board of Directors to meet with and educate not only Cabinet members about municipal issues and the work of the AMM, but MLAs from all the major political parties in Manitoba.

This year's Lobby Day took place on April 23, 2014.

The first meeting of the day was with *Rana Bokhari*, Leader of the Manitoba Liberal Party, and Dr. *Jon Gerrard*. Next, the AMM met with Leader of Official Opposition, *Brian Pallister*, and a number of PC MLAs. Lobby Day concluded with a meeting with the NDP, including Municipal Government Minister *Stan Struthers*, various Cabinet Ministers and MLAs.

During each meeting, the AMM highlighted two major issues to the parties—infrastructure funding and alternate revenue, and economic development. Board members also asked a number of other specific questions, both related to the highlighted topics and other municipal issues.

By all accounts Lobby Day 2014 was successful in communicating the AMM's priority issues and educating Manitoba's major political parties about the concerns of municipal governments.•

Manitoba Cities Caucus meets

On April 16, the mayors of Manitoba's cities met in Brandon to discuss the top issues facing their communities.

According to City of Steinbach Mayor *Chris Goertzen*, who was acclaimed to serve his second one-year term at the helm of the Cities Caucus, questions remain about the design of the New Building Canada Fund. "New rules about stacking of funding and exclusion of local roads from the main component of the fund raise concerns," he said.

The group agreed that given this uncertainty, the need for alternate revenue to fund municipal infrastructure programs is becoming a higher priority. The AMM has lobbied for both a share of the Provincial Sales Tax (PST) to be dedicated to municipal infrastructure, along with a rebate on the PST municipalities pay on infrastructure projects.•

Everything is Local

Local infrastructure is the most critical top-of-mind issue for almost one third of Manitobans, according to a recent poll by Probe Research. The poll "Everything is Local" was commissioned jointly by the AMM, the City of Winnipeg, and the Manitoba Heavy Construction Association to gauge public opinion of local governments and the challenges facing municipalities.

The poll showed that 31% of those surveyed placed infrastructure over other hot-button issues like crime, jobs/economy, taxation or health care.

Respondents were also asked to provide a list of areas they feel require additional municipal spending. More than one half of Manitobans (56%) believe that local governments should spend more money addressing core infrastructure like streets, roads, bridges and water and wastewater projects.

The poll also showed overwhelming support for having revenues from last year's PST increase put in the hands of municipalities. Of those surveyed, 69 per cent expressed the view that the money raised from the PST increase should flow directly to municipalities, as opposed to 23% who feel the provincial government should determine how the money is spent.•
