Minister Meetings Continue

The AMM continued its annual series of Minister meetings on February 10, beginning with the Honourable **Peter Bjornson**, Minister of Housing and Community Development.

Increased funding for housing was the first item on the agenda. The AMM raised various housing needs in the province,

and suggested a seminar to discuss the issues. The AMM also asked about the impact of the federal budget on housing in Manitoba, and for an update on the implementation of the Rental Housing Roundtable Report.

Cuts to the Community Places Program were also raised with the Minister.

Next, the AMM met with the Minister of Children and Youth Opportunities, the Honourable *Kevin Chief*, and began by asking for an update on the childcare strategy. The Minister noted details of a recent review will be announced soon.

The discussion then turned to a possible recreation centre pilot project aimed at reducing operating costs for community centres. The AMM also asked for an update on the recreation policy review recently announced by the Province. The Minister noted the AMM will be asked to participate in the review in the near future.

The AMM next expressed concern that Hometown green teams are not being funded appropriately, and asked how amalgamation might affect this program. The Minister reassured the AMM that he is a great supporter of this program.

Seniors housing and mobility were topics discussed with the Honourable **Sharon Blady**, Minister of Healthy Living and Seniors. Support for the handi-van program and Transportation Options Networks for Seniors (TONS) was also discussed, along with the need for better communication between the age-friendly initiative and accessibility committee.

The need for a solution to the growing costs of police escorts under the Mental Health Act was also raised.

Finally, the AMM met with the Honourable *Ron Lemieux*, Minister of Tourism, Culture, Heritage, Sport and Consumer Protection. The need to increase library funding and to implement a single library card was the first items discussed.

The AMM then pointed out museum funding hasn't been increased in years and asked for a review of the "star attraction" designation policy. The Minister is working through Tourism Manitoba on promoting local attractions.

Improvements in the relationship between the Public Utilities Board were noted, and the Minister promised to consult the AMM when the regulations for the new home warranty legislation are being drafted.•
