Insurance Program Update

Each year on April 1, the AMM renews its Group General Insurance Program. Western Financial Group will send out your renewal documents for the 2015-2016 policy in early April.

Our program combines a large self-funded loss pool with insurance provided by financially strong commercial insurance companies. The strategy has been successful for many years because it allows the program to avoid fluctuations in premiums while at the same time providing the broadest coverage available.

It is also a made-in-Manitoba solution with Manitoba underwriters and claims services. (You may recall that the AMM program was named "best in class" in an independent review conducted a few years ago.)

District Director Elections

The AMM will be conducting elections for the AMM Board of Directors at this year's June's District meetings.

This will be for a two-year term until June of 2017.



The main qualifications to be a director on the AMM Board are:

- you must be an elected official from a member municipality of the AMM;
- in the Northern District, you must be an elected official from the municipality in the northern part of the district you wish to represent as outlined in the AMM bylaws
- In all other Districts, as a result of our changes to the bylaws at last year's Annual Convention, the urban/rural designations for directors are eliminated and we will be electing two directors at large.

It is also important to note that all elected officials and CAOs in the district are eligible to vote for both director positions.

Private Water System Bacteriological Subsidy Program

The Province of Manitoba offers private water system owners a oncea-year subsidy for bacteria (total coliform and E. coli) analysis of their drinking water through Horizon Lab. If the first sample result indicates a



water quality concern (total coliforms > 10 and/or E. coli >0), homeowners will receive a coupon from the lab for one resample free of charge.

Effective April 1st, 2015, the total price to homeowners for the once-a-year subsidized sample is \$21.26 (tax included). For information regarding sample bottle pick up, sample submission requirements, and payment options, please contact Horizon Lab directly.

The Association of Manitoba Land Surveyors had a new Act passed in the legislature in December of 2013. Under the new Act the Association is required to have public (lay) representation on its Executive Council, Discipline and Practice Review Committees. This requirement will come into effect when the new Act is proclaimed. We expect that proclamation will be by years end or early in 2016.
