85% of Manitobans Agree

Local Councils deserve their **FAIR SHARE** of infrastructure tax dollars and a **FAIR SAY** in how they're spent.

That's because they're responsible for 60% of the infrastructure work but receive just 8 cents of every tax dollar to get the job done.

In a recent <u>public opinion poll</u> conducted for the AMM, 85% of Manitobans agreed that local councils across the province deserve both a Fair Share of infrastructure tax dollars and a Fair Say in how they're spent.

"In Manitoba, local Councils are responsible for 60% of infrastructure yet receive just 8 cents of every tax dollar to get the job done," said AMM President Chris Goertzen. "Adding to the pressure is that we often have little to no say in how the rest gets spent - despite the fact that we live and work in the communities we represent, so are in the best position to identify top priorities."

In launching a six week, multi-media "Fair Share - Fair Say" campaign leading up to the next provincial election, Goertzen was backed by Winnipeg Mayor, Brian Bowman and Mayors and Reeves from across the province.

One of the campaign's main goals is to encourage Manitobans to join them in speaking with one voice when it comes to advocating for improved infrastructure.

2016 Manitoba Public Insurance Rates

Each year on March 1, rates for basic and complex fire fighting payments made by Manitoba Public Insurance are increased, based on the prior year's C.P.I. plus 1 %.

Effective March 1, 2016, the basic call rate will increase from \$771 to \$788, and the complex call rate will increase from \$1,028 to \$1,051. These increases are based on the 2015 Manitoba C.P.I.

By 2050, the percentage of the world's population over the age of 60 will nearly double from 12% to 22%. This demographic shift is already impacting municipalities as the needs of seniors are placing greater demands on local service delivery.

In this Public Sector Digest webinar, our expert panel will discuss how municipalities can proactively address the issues surrounding an aging population - from raising park benches to ensuring that transit stops are within a short walking distance of shopping centres.

This webinar will be of great interest to communities just starting to look at the challenge of an aging population, as well as for those with a strategy already in place.

Material Disposal Bans Webinars

Environment ministers are committed to taking action within their jurisdictions and through CCME to continuously improve Canada's record on reducing and recycling waste. CCME is developing tools and best practices to assist jurisdictions to achieve substantial reductions in waste disposed.

A 2014 State of Waste Management report commissioned by CCME (available at http://bit.ly/1SIWtJs) identified increased use of jurisdiction-wide disposal bans, particularly for materials with diversion infrastructure in place and for extended producer responsibility (EPR)-designated materials, as an opportunity to increase diversion and reduce disposal of waste.

Some Canadian and international governments have implemented jurisdiction-wide or partial material disposal bans; several Canadian municipalities have also implemented material disposal bans. In this webinar series, CCME will explore the lessons learned and best practices from these experiences.
