At the AMM Convention, the Minister of Growth, Enterprise and Trade stated the government would survey AMM to ask if municipalities would be participating in the province's strategy to establish retail cannabis stores in communities across the province.

On December 6, the AMM distributed survey questions to AMM Members on behalf of the Department of Growth, Enterprise and Trade.
