#### Latest News

Municipalities now eligible applicants for the Canada-Manitoba Job Grant (CMJG)

In response to AMM Resolution #30-2015, the AMM is pleased to report that municipalities will be considered eligible applicants for the Canada Manitoba Job Grant (CMJG) going forward.

The intake of applications for the Canada-Manitoba Job Grant is now open.

The intake is for training delivered between September 2018 and

The application intake closes on September 14, 2018.

To apply for the CMJG, employers (i.e., municipalities) must contact Manitoba Education and Training by phone/email to request an application (contact information is listed on the fact sheet). In turn, the department will send the employer instructions on how to complete and submit the application.

#### Manitoba to replace Public Safety Communications Service

On August 8, 2018, the Manitoba government announced that Bell MTS was awarded a tender for the replacement of the province's public safety communications service. Total project costs for the replacement of the public safety communications service is expected to be \$380 million, while the new system will be implemented over the next three years.

Farmland Beaver Damage Control program provides financial assistance to Rural Municipalities, Association of Manitoba Community Pastures, Northern Association of Community Councils and First Nation Community Band.

The program will offer financial assistance for direct and indirect methods of removing nuisance beavers. Expenses will be costs shared at 50:50 to a maximum of \$15/beaver and \$200/pond leveler.
