AMM launches new website

Regular visitors to the AMM website will have noticed a considerable change over the past couple of weeks. The AMM launched a brand new website on October 20, immediately prior to the municipal election. The previous website was designed almost a decade ago and was in need of a complete overhaul, so back in the spring, the AMM underwent a Request for Proposal process. Four companies submitted proposals and after a series of presentations, the AMM chose Manoverboard to perform the work and build the new website.

The new website includes a number of new and improved features:

- An interactive member map showing each district and municipality (after amalgamation), the AMM Directors for that district, and links to each municipal website;
- A searchable database of all AMM documents and publications;
- · An expanded Events section
- A new system for submitting classified ads and job postings
- An "Issues" section detailing the AMM's top policy issues.

"Our focus is entirely on the user and their diverse information needs," says Manoverboard's Andrew Boardman. "The site features a well-planned and user-friendly navigation at the top that will quickly orient any visitor to where they want to go. Congratulations Elected Officials!

Now that the excitement of election night has come and gone, the AMM is pleased to welcome 355 new members of council - 39% overall.

With 553 returning members of council and 5 vacancies there are 913 elected positions in total (after amalgamation).

Congratulations to all council members, both newly and re-elected, on taking on this important role within your local government

A few other stats jump out from this year's election, most notably the percentage of women elected. This year, 17% of those elected to serve until 2018 are women - a 3% increase over 2010.

The AMM is busy preparing welcome packages for the new council members along with welcome back packages to those re-elected.

Voting Reminder

Because municipal councils in amalgamated municipalities will not be officially sworn in until January 1, eligibility for municipal officials to vote is limited to a member of council holding an elected municipal office.

Given the impact this may have on voting during the AMM Annual Convention, we strongly encourage <u>voting delegates</u> to ensure they attend the following sessions:

1. AMM Annual Business Meeting Tuesday, November 25–9:00 am

The AMM Annual Business meeting is an important part of Convention. This year, it is especially important that all voting members attend to ensure we have quorum. A number of proposed by-law changes will also be dealt with at 9:30 am, immediately following the Annual Business Meeting.

 Resolution Sessions Tuesday, November 25–3:45 pm Wednesday, November 26–2:30 pm

The outcome of the resolution sessions will determine the AMM's lobbying strategy for the coming year. It is imperative that all voting members attend the resolutions sessions to ensure resolutions are dealt with appropriately.


3. Election of AMM Executive Wednesday, November 26 11:15 am (President) and 1:15 (Vice-Presidents)
