AMM, MMAA meet with PUB

The AMM and the MMAA met with the Public Utilities Board (PUB) on October 3, 2014. The PUB began by reviewing the work done with the MMAA recently. It has developed revised guidelines and new software for submitting rate applications, which should help municipalities avoid the cost of hiring a consultant to complete studies in order to submit an application. A PUB representative will be running training workshops with MMAA in January 2015, which will cover the new guidelines. The possibility of attending AMM District Meetings or the Municipal Officials Seminar in the future was also discussed.

The discussion then turned to PUB work with the Municipal Board around the approval of New Building Canada Fund (NBCF) projects. Since no NBCF projects have been announced, no PUB or Municipal Board approvals have been required yet. The PUB has met with the Municipal Board, and they have discussed using a process where PUB could give preliminary approval to a municipality for a debenture rate based on the amount they would like to borrow before the municipality goes to the Municipal Board for approval.

The next issue raised was the use of remote water readers. PUB indicated they have no authority over the installation or removal of these meters. It is important for utilities to keep in mind working life of these readers and potential replacement costs.

Also discussed was the possibility of utilities potentially looking at combining, particularly in amalgamated municipalities.

AMM and PUB agreed on the importance of open dialogue to resolve issues before they become problems. Having PUB staff available to answer questions from CAOs has been helpful, and progress has been made in the last year.•


