Process for June District Meeting Resolutions

- 1. All resolutions must be submitted to the AMM office prior to June 1st for consideration at that year's June District Meeting. Resolutions received after this date will be considered post-June District Meeting resolutions and will be dealt with through that process.
- 2. Resolutions are categorized by the District Resolutions Committee which is chosen at the meeting. The chair of the District Resolutions Committee sits on the AMM Convention Resolutions Committee.
- 3. Resolutions categorized as 1 or 2 are presented for debate by delegates.
- **4.** Resolutions categorized as a 3 resolution are not put forward for debate, but the AMM Board of Directors later reviews the decision on the category.
- 5. The City of Winnipeg will send resolutions directly to the AMM prior to June 30th. These resolutions will be forwarded to the AMM Convention Resolutions Committee for categorization.

Category 1 Resolutions Passed at the June \rightarrow District Meetings	Reviewed by AMM to determine what immediate \rightarrow action should be taken.	Reviewed and categorized by the Convention Resolutions Committee in September.
	Those categorized as 1 are debated at the AMM Annual Convention in November.	Those categorized as 2 and 3 are reviewed by the board. See chart for convention resolutions.
Category 2 Resolutions Passed at the June → District Meetings	Categorization is reviewed by the AMM Board of Directors. If maintained as a 2, the board decides what action should be taken.	
Category 3 Resolutions →	Categorization is reviewed by the AMM Board of Directors. If changed to a 1 or 2, it will follow the appropriate process outlined above. If maintained as a 3 resolution, no further action is taken.

Resolution Categories

The following categories shall apply to all resolutions submitted for consideration by the Association of Manitoba Municipalities at either the Annual Convention or the District Meetings.

Category 1: Municipal Issues

Category 1 resolutions are resolutions whose outcome has the potential to impact a majority of municipalities. It is possible that the outcome of a Category 1 resolution might not immediately impact all municipalities, but the outcome has the potential to impact a majority of municipalities. This impact may be direct or indirect. Examples of areas of influence of Category 1 resolutions include direct changes to legislation that govern municipalities, such as The Municipal Act, changes to direct funding to municipalities, such as the Provincial-Municipal Tax Sharing Agreement, or more indirect changes to government programs that might impact municipalities, like a change in the Provincial drainage program.

Category 2: Local or Regional Municipal Issues

Local or regional issues are those that affect one region or only a small number of municipal governments. Resolutions in this grouping will be presented at the District Meetings; however, they will not be submitted for consideration at the Annual Convention. A resolution in this category, if passed at the District Meeting, will be dealt with by the Board of Directors as they see fit.

Category 3: Non-Municipal Issues

Non-municipal issues do not affect municipal governments.

Resolutions in this grouping will not be presented at the District Meetings or the Annual Convention; instead, they will be dealt with by the Board of Directors as they see fit.

*** Consideration should be given to whether there are other organizations better equipped to deal with issues than the AMM.
