





The many meetings, committees and taskforces were a great learning experience.

When elected as President of AMM, Doug rented out his farmland to dedicate his time to the association. The family had an interest in horses and in 2010 built Bella Vida Stables, an equestrian centre to board and train jumping horses, and along with Kelly and youngest daughter Alyssa, the trio manages the business.

Today Doug and Kelly have a family of three married children and four grandchildren who are all fortunate to live close by.



RESOLUTIONS COMITTEE

RULES FOR RESOLUTIONS SESSIONS

- 1. When Resolutions commence, members of the Resolutions Committee will read out the operative clauses of a given resolution- i.e., the resolved portion.
- 2. The Chair will move the resolution.
- 3. The Chair will call for a seconder who will second the resolution by providing their name and municipality.
- 4. The seconder will open debate on the resolution. Then any municipal official is welcome to speak in favour or opposition to the resolution at hand; microphones will be labelled specifically for those "in favour" and "opposed".
- 5. Anyone speaking to a resolution will have a maximum of <u>two minutes</u>. The time remaining for speakers will be displayed, counting from two minutes to zero, at which time microphones will be turned off.
- 6. As provided for in Robert's Rules of Order, the Chair will call for speakers alternately from each microphone position. If no speakers with an alternate position request the floor, the Chair may, after entertaining three or more speakers to the one position, end debate even if further speakers to the position have already requested the floor.
- 7. No one may speak twice per resolution unless for clarification.
- 8. The seconder will be invited to close debate.

AMENDMENTS

- 1. Amendments to motions may be introduced by any registered voting delegate. Unlike the "Standing Order" for main motions, the Chair will not move an amendment.
- 2. Once the motion to amend has been introduced, the Chair will decide if the amendment is in order (i.e., does not change the intent of the motion).
- 3. If the Chair decides the motion is in order, they will call for a seconder.
- 4. Once the amendment has been moved and seconded, the motion to amend will be dealt with in the same way as all motions as outlined in the Standing Orders and Rules of Order.
- 5. Unlike main motions, however, amendments to the amendment will not be accepted.
- 6. Discussion on an amendment must address the amendment only and not the merits of the main motion.
- 7. The Chair will entertain only two amendments per resolution.
- 8. Should more than two amendments come forward, the Chair may send the resolution to the Resolutions Committee and the Parliamentarian for their consideration.
- 9. The decision of the Chair is final.

DEBATING STANDING POLICY RESOLUTIONS

- A delegate wishing to debate a Standing Policy resolution must move a motion asking the Chair to "suspend the rules".
- If there is a seconder, the Chair will ask for the vote on the motion. The motion passes if 2/3 of delegates vote in favour of it.
- If the motion is passed, the remainder of the debate follows the normal resolution process.

RESOLUTION CATEGORIES

The following categories shall apply to all resolutions submitted for consideration by the Association of Manitoba Municipalities at either the annual Fall Convention or District Meetings.

CATEGORY 1: MUNICIPAL ISSUES

Category 1 resolutions are resolutions whose outcome has the potential to impact a majority of municipalities.

It is possible that the outcome of a Category 1 resolution might not immediately impact all municipalities, but the outcome has the potential to impact a majority of municipalities. This impact may be direct or indirect.

Examples of areas of influence of Category 1 resolutions include direct changes to legislation that govern municipalities, such as The Municipal Act, or more indirect changes to government programs that might impact municipalities, like a change in the provincial drainage program.

Category 1 resolutions, if passed at the District Meetings, will be brought forward to the main Resolutions Committee for consideration at the Annual Convention.

CATEGORY 2: LOCAL OR REGIONAL MUNICIPAL ISSUES

Category 2 resolutions deal with local or regional issues that affect one region or only a small number of municipal governments.

An example of a Category 2 resolution would be a resolution dealing with a necessary improvement to a specific local road.

Resolutions in this grouping will be presented at the District Meetings; however, they will not be submitted for consideration at the annual Fall Convention. A resolution in this category, if passed at the District Meeting, will be dealt with by the Board of Directors as they see fit.

CATEGORY 3: NON-MUNICIPAL ISSUES

Non-municipal issues do not affect municipal governments.

Resolutions in this grouping will not be presented at the District Meetings or the annual Fall Convention; instead, they will be dealt with by the Board of Directors as they see fit.

WHEREAS municipalities in rural Manitoba do not receive their fair share of funding from Manitoba's Strategic Municipal Investment Fund, where they receive only 29% (\$50.8M) of unconditional funding, while the City of Winnipeg receives 71% (\$121.2M); and

WHEREAS this funding formula is based on per capita funding formula for communities outside the City of Winnipeg, so that less densely populated areas of Manitoba receive less funding even while they support major industries (such as agriculture, oil and gas) which provide a significant contribution to the GDP of Manitoba and require significant infrastructure to support; and

WHEREAS large investments are needed to support municipal infrastructure outside the City of Winnipeg, so that these communities can better support existing industries and also better prepare for growth;

THEREFORE BE IT RESOLVED THAT the AMM lobby the Province of Manitoba to review and revise the funding formula of the Strategic Municipal Investment Fund to include not only funding based on population, but to include a funding model that also provides funding to support infrastructure costs (e.g., number of road miles maintained) so that communities outside of Winnipeg can make significant contributions to the economy of the province.

WHEREAS Section 3 of The Municipal Act identifies Municipal purposes that obligates municipalities to provide good government, services, facilities, or other things that in the opinion of the council of the municipality, are necessary or desirable for all or part of the municipality and to develop and maintain safe and viable communities; and

WHEREAS a municipality is reliant upon the traditional and primary source of revenue of the annual tax levy; and

WHEREAS there are demands on municipalities to provide and expand public services within these limited resources; and

WHEREAS there is downward pressure from ratepayers to reduce taxes; and

WHEREAS municipalities have become reliant on conditional and unconditional grants from other levels of government to offset costs and sustain operations; and

WHEREAS these grants are unpredictable and difficult for municipalities to prepare long-term financial planning; and

WHEREAS Manitoba has imposed a funding freeze that is currently at seven consecutive years; and

WHEREAS there are limited additional revenue generating tools at the municipality's disposal for non-traditional revenue; and

WHEREAS municipal governments need access to additional revenue streams to provide public services;

THEREFORE BE IT RESOLVED THAT the AMM lobby the Province of Manitoba to undertake a comprehensive cross-jurisdictional and national review and analysis of local government revenue generation options for consideration.

Recreational Facilities Safety Procedures

WHEREAS arenas, rinks, and indoor ice surfaces are often the main recreational facilities for municipalities around the province in the winter months; and

WHEREAS regulations governing the operations of ice plants have been tightened across Canada in response to the tragedy at an arena in Fernie, B.C.; and

WHEREAS municipalities, recreation boards and recreation complexes are struggling to maintain sufficient certified staff to keep arenas open due to power engineering certification requirements, resulting in facility closures and lack of access to recreation;

WHEREAS the high levels of phosphorus in the lake are a significant contributing factor to the increased frequency and severity of algae blooms developing along many beaches during the summer season; and

WHEREAS the City of Winnipeg has a plan in place, as approved by Manitoba Conservation and Climate in November 2019, to proceed with a major infrastructure upgrade program, called the Combined Sewer Overflow (CSO) Master Plan, to manage the effects of combined sewer overflows (CSOs) on our waterways; and

WHEREAS the City of Winnipeg continues to discharge sewage that contains high levels of phosphorus that do not meet its provincial operating licence increasing the nutrient load and further exacerbating the deterioration of the raw Lake Winnipeg water quality; and

WHEREAS the City of Winnipeg's decision to reject the Lake Winnipeg Foundation and International Institute for Sustainable Development's proposal to use ferric chloride to reduce the substantial amount of phosphorus being dumped into Lake Winnipeg by up to 70% will result in the continued discharge of high levels of phosphorus by the City into Lake Winnipeg; and

WHEREAS Lake Winnipeg is of vital importance to all stakeholders including indigenous peoples, fishers, cottagers, residents, as well as communities that use the lake as a source of economic growth or stability, and many other user groups who are presently negatively impacted by the unacceptable and unsustainable condition of the lake;

THEREFORE BE IT RESOLVED THAT the AMM lobby the provincial and federal governments to devise a plan of action to immediately mitigate the discharge of high phosphorus levels contributing to the deteriorating condition of Lake Winnipeg and ensure compliance with its operating license issued pursuant to The Environment Act.

WHEREAS DEF is prone to clogging, causing many maintenance and repair issues and much downtime. These systems are complicated in design and a simple clogged filter can cause pressure and temperature differentials that can affect the whole performance of the engine; and

WHEREAS DEF's freezing point is-15 Celsius and not suitable for Manitoba winters; and

WHEREAS fuel companies do not provide bulk DEF, creating environmental problems from the production and pollution of small containers; and

WHEREAS it is cost prohibitive to maintain this equipment creating Manitoba businesses that are non-competitive in their industries and ultimately hurting an already struggling supply chain; and

WHEREAS municipalities require these vehicles and experience costs for downtime and maintenance, resulting in loss of service to their taxpayers due to the downtime and higher taxes due to additional maintenance costs;

THEREFORE BE IT RESOLVED THAT the AMM lobby the Government of Canada to make the DEF requirement optional on medium- and heavy-duty vehicles with diesel engines, and

FURTHER BE IT RESOLVED THAT the AMM lobby the Province of Manitoba to provide a DEF delete option for owners requiring Manitoba Safety to register the medium and heavy-duty vehicles with diesel engines.

WHEREAS Manitoba Transportation and Infrastructure has installed gates at three intersections in and around Virden on the Trans Canada No. 1 Highway that can be closed at the discretion of the RCMP, with little notice to the motoring public, when they feel that the highway is unsafe for travel; and

WHEREAS gates have not been installed at the Saskatchewan-Manitoba Provincial border or signage advising the motoring public of road closures ahead; and

WHEREAS this results in hundreds of motor vehicles, including passenger and tractor trailer units, being stopped along the highway and service roads starting at the intersection of King Street East and the Trans Canada No. 1 Highway, for several kilometres in both directions; and

WHEREAS the motor vehicles, in particular, the tractor trailer units, tend to park three abreast, making it virtually impossible for emergency vehicles, or service vehicles to gain access down the highway or for a passenger vehicle egress off the highway into Town; and

WHEREAS this can create dangerous conditions and life-threatening situations for first responders and those who are stuck within the traffic and in need of medical assistance; and

WHEREAS in other countries, legislation has been put in place prohibiting the parking of three abreast on a public roadway, during any road closure, which keeps, at minimum, one land open for first responders or those attempting to get off the roadway into a service center; and

WHEREAS in other Provinces across Canada, signage has been installed warning travellers of road conditions and potential road closures, several kilometres in advance, so they have the opportunity to stop at other service centers in advance of the closure, eliminating the long lines of congested traffic in and around the Town of Virden or any other urban center that gates have been installed at;

THEREFORE BE IT RESOLVED THAT the AMM lobby the Province of Manitoba to have appropriate signage placed in strategic locations across the province which will serve as early warning systems to the motoring public of conditions ahead that may affect travel; and

FURTHER BE IT RESOLVED THAT the AMM lobby the Province of Manitoba consider adopting legislation that will prohibit vehicles from parking three abreast during any road closure, leaving one lane open for access for emergency responders, service vehicles and those wishing to access service centers.

WHEREAS Emergency Medical Responders are on call volunteers who live in the local community and are medically trained personnel who are dispatched to medical emergencies and in most cases are on scene prior to the arrival of an ambulance which in many cases can be 30 minutes to an hour; and

WHEREAS consultations with municipalities and Emergency Medical Responder Programs throughout the Province have identified the need for a different classification for volunteer Emergency Medical Responders outside the mandate of the College of Paramedics;

THEREFORE BE IT RESOLVED THAT the AMM to lobby the Province of Manitoba to create a licensing level for Volunteer Emergency Medical Responders under the Department of Health to sustain the model that has been in place for many years and has been successful in allowing Emergency First Responder programs to remain viable and sustainable.

WHEREAS several members of the ambulance crew incurred frost/freezing injuries as they were not properly dressed/equipped for the needed response; and

WHEREAS as a result of this incident IERHA (North Eastman Health Authority at the time) implemented a policy that stopped the ambulance crews from leaving their ambulance's immediate area or the road surface where it was parked; and

WHEREAS this seems to be a policy that has not been implemented in other Regional Health Authorities within the Province; and

WHEREAS the responsibility for rescue and initial assessment and treatment has now shifted to the responding NEMAD Fire Dept. thus delaying needed treatment that could/should be provided by a paramedic and as such further endangering the victims/patients of the incident; and

WHEREAS some of these incidents occur well off the roadway resulting in rescue operations that can take a considerable amount of time, up to an hour or more, the victim/patient is being put at undue risk; and

THEREFORE BE IT RESOLVED THAT the AMM lobby the Province of Manitoba to have this policy changed to allow the ambulance crews to again go off of the road to assist in the rescue and treatment of those injured in the incident; and

FURTHER BE IT RESOLVED THAT the AMM lobby the Province of Manitoba to have IERHA provide the needed cold weather and all-weather gear to allow the ambulance crews to respond without putting them at risk to inclement weather conditions, in accordance with current Workplace Safety and Health Regulations; and

FURTHER BE IT RESOLVED THAT if this is not done the NEMAD Fire Depts. will be forced to call for STARS to deal with issues where ambulance crews could and should be responding and dealing with the incident.

WHEREAS with the increasing costs of policing there is a greater onus on all communities and municipalities for increased by-law enforcement and with these processes there are also greater liabilities and costs; and

WHEREAS despite the efforts of the provincial government to provide direction on the issue of by-law enforcement through The Manitoba By-law Enforcement Act and the Provincial offences notice legislation, the issue of by-law enforcement officers having "Peace Officer" designation remains unresolved; and

WHEREAS on March 2, 2022, Manitoba Justice and Municipal Relations sent a memo to all communities and municipalities within Manitoba, which highlighted the necessity of by-laws and their enforcement and then pointed to the limitations of by-law officers and their lack of "peace officer" authority; and

WHEREAS the membership of the AMM has passed resolution #42/09 requesting and supporting a comprehensive review of The Provincial Police Services Act, which is currently ongoing; and

WHEREAS by-law enforcement is an important component of policing and overall public safety; and

WHEREAS the courts in Manitoba have recognized by-law enforcement personnel as having peace officer status; and

WHEREAS Manitoba Justice has been provided with additional legal precedents and authorities, which also support the premise that By-Law Enforcement Officers are recognized as peace officers; and

WHEREAS the Province through the review of The Police Services Act is responsible for the development of training standards and regulations which govern all police services, and these standards and regulations should also be developed to govern by-law enforcement personnel;

THEREFORE BE IT RESOLVED THAT the AMM lobby the Province of Manitoba request that the regulation and training standards, for by-law enforcement officers be clearly defined and included within the ongoing review of The Police Services Act; and

FURTHER BE IT RESOLVED that upon and within the development of these regulations and standards the issue of "peace officer" designation of bylaw enforcement be formally addressed, as this would greatly assist all municipalities and communities with by-law enforcement and thereby also enhance public safety.

WHEREAS communities benefit from efforts toward coordinated safety and well-being concepts; and

WHEREAS Manitoba Justice announced on April 29, 2022, their support for a Community Safety and Well-Being Planning Pilot Project that will develop and implement plans for 12 communities; and

WHEREAS every municipality in Manitoba could benefit from reviewing available resources and identifying local priorities to create a safer and healthier community;

THEREFORE BE IT RESOLVED THAT the AMM lobby the Province of Manitoba to encourage all municipalities to work toward creating a Community Safety and Well-Being Plan, with appropriate Provincial funding to do so.

AMM Resolution #30-2022

Farmland Portioned Assessment – Standing Policy

WHEREAS the Province is committed to ensuring that Municipalities have the tax tools available to distribute the municipal tax burden among ratepayers fairly and sustainably; and

WHEREAS the Province recently provided Municipalities with an extension to differential mill rate authority until December 31, 2024; and

WHEREAS the Municipality of Ste. Rose completed the transition to a unified mill rate at the time of amalgamation (2015); and

WHEREAS the reassessment in 2016 reflected a substantial increase of 39.7% and an additional increase of 16.4% in 2018 in the farmland taxable assessment; and

WHEREAS the Province of Manitoba authorized a decrease in the percentage for portioning for farmland in the year 2002, from 30% to the present percentage rate of 26%;

THEREFORE BE IT RESOLVED THAT the AMM lobby the Province of Manitoba to re-assess and decrease the portioning associated with farmland in order to distribute the municipal tax burden among ratepayers in a fair and sustainable manner.
