Property & Casualty Program Structure

- "Protected self-insurance", with annual AMMheld loss pool that pays 1st portion of claims
- Excess insurance provided by commercial insurers for complete protection
- Un-used loss pool funds belong to municipalities
- Ongoing review and enhancement of coverages





- "Guaranteed replacement cost" protection for buildings, also for mobile machinery and equipment up to 10 years old
- \$35,000,000 liability protection
- ** Environmental Impairment liability increased from \$2,000,000 to \$5,000,000
- Crime, boiler and accident coverage





April 1, 2015 Property/Casualty Renewal

- Claims in 14-15 policy year were \$5,913,723 (as of May 31, 2015)
- Total insured values for 2015 Renewal -\$4.51 Billion up from \$4.27 Billion in 2014
- 6 insurers share the program property risks on renewal





- 4.0% increase in total cost to municipalities \$12,256,000 as at April 2014 up to \$12,796,000 on renewal April 1, 2015
- Self-Insurance loss pool \$6,100,000
- Excess insurance cost \$6,696,000, up from \$6,155,000 (which includes the Environmental Impairment Liability increase to \$5,000,000)





Amalgamated Municipalities

- Number of municipalities down from 196 to 137
- Most amalgamated municipalities saw premium reductions, some of up to 10% (3 into 1) due to the rating method for both the Liability and Council AD&D coverages (which are based per municipality)





Accidental Death & Dismemberment

- This is the accident cover for Councillors, Volunteer Firefighters/Ambulance Attendants and Other Volunteers
- Benefits have been improved to match those offered in marketplace
- The maximum age of persons covered has been increased from 65 to 80
- Availability for Councillors and Firefighters for 24/7 cover and family cover
- Details on improvements to coverages will be sent to municipalities later this month

April 1, 2015 Property/Casualty Renewal

- The program surplus has grown from \$306,000 March 31, 2008 to \$2,388,841 May 31, 2015, surplus is owned by municipalities; program is stable
- \$2,000,000 is retained for "incurred-but-notreported" claims
- *\$7,792,090 has been returned since 2004*





Risk Management

- Continue to complete risk reviews of municipal buildings and recreational facilities (280 buildings reviewed in past year)
- Assist municipalities with questions about property claims and liability issues
- Assist AMM with Risk Management concerns related to safety plans and COR Certification for municipalities





Risk Management

- Prepare Loss Prevention bulletins and articles for Municipal Leader magazine
- Present Risk Management and Loss Prevention seminars at MOS
- Provide ongoing training courses for municipal Playground inspectors





Health and Dental

- Self-insured since Jan/05, with claim payment services by Manitoba Blue Cross
- Accumulated surplus owned by municipalities \$1,117,186 as at April 30, 2015
- Average annual premium increase 2.8% in last 5 years, much lower than other group benefit plans





Health and Dental

- 116 municipalities participate, plus 284 others like conservation districts, recreation, planning districts, weed districts, and retirees
- 1,878 employees/Councillors insured, 4,869 including dependents
- Total premiums now \$4,743,000 annual.
