



Education Property Tax

Education Support Levy

- applied to other (mainly commercial) property
- 2018 mill rate 9.77 on other property
- residential exempt since 2006
- farmland and outbuildings exempt since 1990
- \$180.9 million 2018

Special Levy

- applied to all properties in the division
- \$1,048.3 million in 2018

Education Taxation Across the Provinces

- All provinces use provincial general revenue
- 7 of the 10 provinces use a school property tax that is determined at the provincial level
- Only Manitoba uses locally determined school property tax
- All provinces benefit from federal transfers and other sources of revenue
