## Manitoba Heritage Trust Program

#### The purpose:

- Building sustainability through new permanent endowments for heritage organizations
- Up to \$5 million in stretch grants for all new endowments
- Three-year timeline (2018-2021)

## Manitoba heritage organizations

Manitoba is home to well over 200 heritage organizations spread across our province

- Museums
- Archives
- Historical Sites

That are of real cultural significance to who we are as Manitobans

## Manitoba heritage organizations

We know our heritage organizations provide real value to our communities; however, they are not without their challenges:

- Small size
- Availability of volunteers
- Sustainable funding





## Manitoba Heritage Trust Program: Why the program is important

While size/volunteers can be consistent challenges for some heritage organizations, the greatest challenge (and sometimes linked) is that of:



How do we ensure that future generations of Manitobans can enjoy our museums and archives and retain that link to our past?





## Manitoba Heritage Trust Program: Why the program is important

The Manitoba Heritage Trust Program aims to help answer the sustainable funding issue through the creation of:



#### **Permanent endowments**

Providing predictable and growing cash flows **forever** through the investment of grants and gifts now



## Manitoba Heritage Trust Program: Why the program is important

Permanent endowments have been used throughout our province's history to support the priorities we care most about:

- Healthcare
- Education
- Community living

For the first time, we are turning our full attention to our heritage organizations so that they too may benefit over the long-term





# The program and its processes (or: How the program works)

## The program (in general)

#### Major program process steps:

- 1. Qualify through an application
- 2. Complete the funding agreement
- 3. Launch the Heritage Trust Fund
- Grow the fund





#### 1. Qualify through an application

Local heritage organizations must apply

 Complete the Manitoba Heritage Trust Program application form that is available on the Endow Manitoba website: <a href="https://www.endowmanitoba.ca/manitoba-heritage-trust-program/">www.endowmanitoba.ca/manitoba-heritage-trust-program/</a>





#### 2. Establish funding agreement

Once a heritage organization is qualified

 They must work with a Manitoba community foundation (CF) to enter into a three-way funding agreement with The Winnipeg Foundation





#### 3. Launch the Heritage Trust Fund

Once the funding agreement has been established, the heritage organization must:

 Obtain a minimum \$2,500 to deposit in order to launch their Heritage Trust Fund





#### 4. Grow the fund

Once the Heritage Trust Fund is launched, the qualifying heritage organization can begin to grow it through **eligible** gifts:

- Deposited into Heritage Trust Fund from April 1, 2018 to March 31, 2021
- All gifts must be received and receipted by The Winnipeg Foundation





#### 4. Grow the fund

Examples of gift types:

- Cheques (payable to The Winnipeg Foundation) and/or cash
- Credit cards transactions (through Endow Manitoba); can set up automatic payments (i.e. pledges)
- Publicly-traded shares (securities)
- Fundraising activities (net proceeds)
- Organizational membership dues





#### 4. Grow the fund

Non-eligible gifts:

- Gifts in kind such as artifacts
- Capitalization of the spending generated from the Manitoba Heritage Trust Program Fund
- Gifts received or raised before April 1, 2018 (i.e. reserve accounts)
- Gifts derived from government sources: Federal, Provincial, or Municipal (I know, we will get to that)

## Program impact: The power of forever

The Heritage Fund is a **permanent endowment** expertly managed by The Winnipeg Foundation and its community foundation partners

 Permanent endowments represent one of the strongest (and safest) means for organizations to achieve sustainable and growth-based funding





## Program impact: The power of forever

Another benefit of the Manitoba Heritage Trust Program is the opportunity it creates through the establishment of a permanent endowment for your heritage organization

 Whether it is in the next few years or the next several decades, an endowment fund creates a mechanism by which your supporters can leave lasting legacies

However, the Manitoba Heritage Trust Program is different than most permanent endowments thanks to the involvement of the Manitoba government





## **Program impact: Stretching grants**

#### Highlights:

All eligible gifts to a participating Heritage Fund received from April 1, 2018 to March 31, 2021, will receive (from the Manitoba government) a guaranteed "stretch" of:

- One dollar for every two dollars raised
- To a "maximum" of \$25,000





## **Program impact: Stretching grants**

Highlights (continued):

If there are funds still remaining in the program at the end of the three years, there are two ways heritage organizations can benefit:

#### "Bonus" Stretch:

• The \$1 for \$2 raised (50% top up) stretch will continue up to an additional \$60,000 in "bonus" stretch grants

#### Or

• If there is not enough money remaining for this "bonus" stretch, the balance will be distributed on a pro-rated basis





## **Program impact: Cash flow**

#### Highlights:

Once the Heritage Fund is initiated, it will begin to pay out annual cash flows to your heritage organization at a rate of 4% per year

- The actual cash amount will be dependent on how much the endowment is funded (i.e. how much is invested)
- The fund and the actual cash flow will increase each year to ensure that the real value of the cash "grows" with inflation





#### Cash flows to your heritage organization

Real life example 1:

- Raise \$10,000 in total for the endowment
- Receive an additional stretch of \$5,000
- Apply the spending policy rate of 4%

#### **Generates**

\$600+/year

For your local heritage organization forever





#### Cash flows to your heritage organization

Real life example 2:

- Raise \$25,000 in total for the endowment
- Receive an additional stretch of \$12,500
- Apply the spending policy rate of 4%

#### **Generates**

\$1,500+/year

For your local heritage organization forever





#### Cash flows to your heritage organization

Real life example 3:

- Raise \$50,000 in total for the endowment
- Receive an additional stretch of \$25,000
- Apply the spending policy rate of 4%

#### **Generates**

\$3,000+/year

For your local heritage organization forever

# Recent program developments and next steps (or: Where we go from here)

## **Recent developments**

### Since launching in April 2018

- **31 heritage organizations** have applied to join the program
- Including three that were directly supported by their municipalities
- **22 funds** have already been created (with another six in progress)
- **\$200K** raised through community efforts
- \$100K added through stretch grants

The Manitoba Heritage Trust Program is gathering momentum

- But the clock is ticking...(less than 28 months to go)
- And there is \$4.9 million in stretch grants "sitting on the table"

**Endow Manitoba staff will continue** 

- Bringing awareness of this opportunity to community foundations, heritage organizations, and municipalities
- Providing administrative support, developing additional program materials, and facilitating partnerships
